BE IT ORDAINED BY THE COMMON COUNCIL, OF THE City of Evansville, Indiana, as follows:

SECTION I:

Pursuant to the requirements of IC 36-4-7-2, salaries of the elected officials of the City shall be as stated below, and the salaries here may not be altered during the year for which they are fixed:

Mayor	\$ 100,534
City Clerk	\$ 63,939
City Council Members	\$ 19,938

SECTION II.

This Ordinance shall be in full force and effect January 1, 2015 through December 31, 2015, and after its passage by Common Council, signing by the Mayor, notice to and hearing of, all as such may be required by law.






