AN ORDINANCE OF THE COMMON COUNCIL
OF THE CITY OF EVANSVILLE, INDIANA
APPROPRIATING MONIES FOR THE PURPOSE
OF DEFRAYING THE EXPENDITURES OF EVANSVILLE-VANDERBURGH
LEVEE AUTHORITY DISTRICT FOR THE
FISCAL YEAR BEGINNING JANUARY 1, 2016

BE IT ORDAINED BY THE COMMON COUNCIL, OF THE City of Evansville, Indiana, as follows:

SECTION I: APPROPRIATIONS

That for the expenditures of the Evansville-Vanderburgh Levee Authority District for the fiscal year beginning January 1, 2016, and ending December 31, 2016, the following sums of money are hereby appropriated for the purpose herein specified, subject to the laws governing the same. Such sums herein appropriated, shall be held to include all expenditures authorized to be made during the year, unless otherwise expressly stipulated and provided by law. Please refer to 2016 Proposed Budget Book for details. Subject to the approval of raises at the budget hearing.

SECTION II: EFFECTIVE DATE

This Ordinance shall be in full force and effect January 1, 2016, through December 31, 2016, and after its publication, passage by Common Council, signing by the Mayor, notice to and hearing of, all as such may be required by law.
