

**AN ORDINANCE AMENDING CHAPTER 13.15  
(WATER)  
OF THE EVANSVILLE MUNICIPAL CODE**

WHEREAS, water rates are regulated by the Indiana Utility Regulatory Commission (“IURC”); and

WHEREAS, the IURC approved various changes and additions to water rates and charges by its Order entered and approved by Conference Minutes dated December 30, 2015; and

WHEREAS, as a result of such changes and additions approved by the IURC, the Evansville Water and Sewer Utility recommends that Chapter 13.15 of the Evansville Municipal Code be amended; and

WHEREAS, the City Council of the City of Evansville (“City Council”) wishes to adopt such recommendations by amending Chapter 13.15 of the Evansville Municipal Code.

NOW, THEREFORE, BE IT HEREBY ORDAINED by the City Council of the City of Evansville, Indiana, that Chapter 13.15 of the Evansville Municipal Code is hereby amended as follows:

SECTION 1. AMENDMENT OF SUBSECTION (E) OF SECTION 13.15.100 OF THE EVANSVILLE MUNICIPAL CODE.

Subsection (E) of Section 13.15.100 of the Evansville Municipal Code shall be amended by changing the figure “\$1,550.00” to read “\$1,635.00”, and by changing the figure “\$1,600.00” to read “\$2,080.00”.

SECTION 2. AMENDMENT OF SUBSECTION L of Section 13.15.100 OF THE EVANSVILLE MUNICIPAL CODE.

Subsection L of Section 13.15.100 of the Evansville Municipal Code shall be amended by deleting said Section as presently constituted and substituting in lieu thereof the following:

“(L) Other Fees


Reconnection charge	\$45.00
Bad check charge	\$23.00
Residential customer meter deposit	\$40.00

Commercial/industrial customer meter deposit	\$65.00
Meter test fee (customer request)	\$60.00
Meter re-read fee (customer request)	\$34.00
Damaged meter fee (customer negligence):	
3/4" meter	\$215.00
Larger than 3/4" meter	Actual costs
Damaged Smart Point (customer negligence)	\$160.00

SECTION 3. EFFECTIVE DATE.

This Ordinance shall be in full force and effect after its passage by the City Council and signing by the Mayor.


